Our Hospital

El Paso Children's Hospital (EPCH) is the only independently licensed non-profit pediatric specialty hospital in the region dedicated exclusively to the provision of high quality medical care for the children of El Paso, Texas and the surrounding area. EPCH is one of only 250 hospitals in the country that specialize in pediatrics, and one of 7 members of the Children's Hospital Association of Texas. EPCH is affiliated with the Texas Tech University Health Science Center (TTUHSC), University Medical Center of El Paso (UMC), and pediatric medicine providers from every corner of El Paso. Through its affiliation with UMC, TTUHSC, and Community providers, EPCH is able to provide an unmatched level of coordinated care to create better experiences for patients and their families.

Background

In order to fulfill the requirements of Section 501(r)(3) of the US Tax Code, not-for-profit hospitals must conduct a Community Health Needs Assessment (CHNA) at least once every 3 years. Additionally, they are required to adopt an Implementation Strategy to address the health needs identified in the CHNA shortly thereafter. EPCH has conducted this CHNA and Implementation Strategy for its hospital facility as required by Internal Revenue Code, section 501(r).

Our Community

For the purposes of the CHNA, EPCH defines the Community it serves as El Paso County, Texas (Community), as the overwhelming majority of inpatient patients draw from this area.

The County of El Paso is located in far west Texas, along the US-Mexico border. On the Mexican side of the border, the population of Ciudad, Juarez exceeds that of El Paso, Texas. A total of 865,657 people reside in area of approximately 1,013 square miles.

Current population demographics and changes in demographic composition over time play a determining role in the types of health and social services needed by Communities. This indicator reports total population and the population density. Population density is defined as the number of persons per square mile of land area. Data are obtained from the Census 2020. A total of 865,657 people live in the 1,013.23 square mile report area defined for this assessment. The population density for this area, estimated at 854 persons per square mile, is greater than the national average population density of 94 persons per square mile.

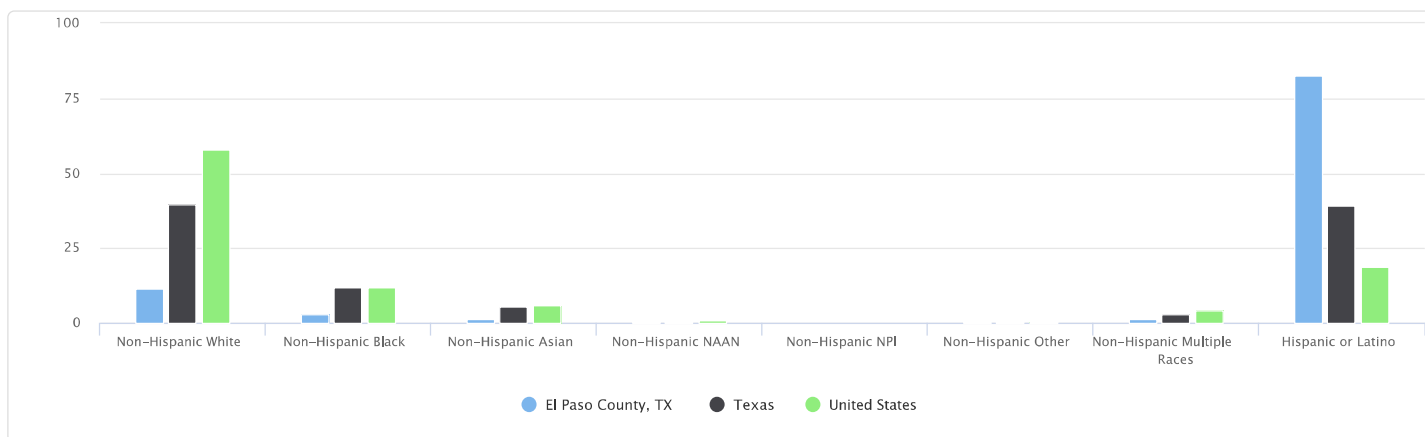

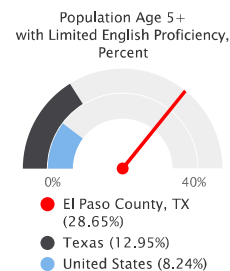

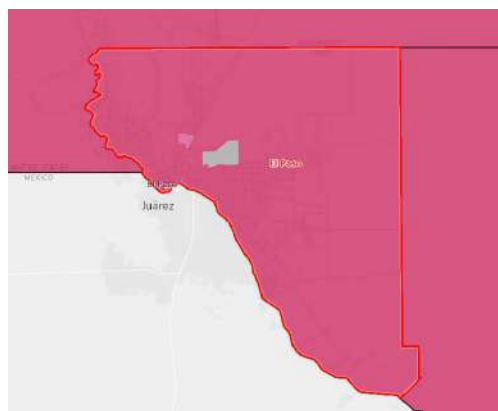

POPULATION WITH LIMITED ENGLISH PROFICIENCY, PERCENT BY TRACT, ACS 2018-22

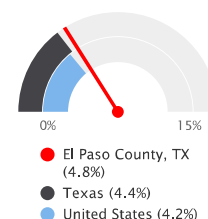

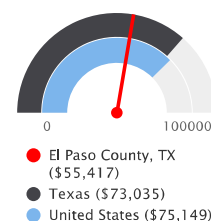

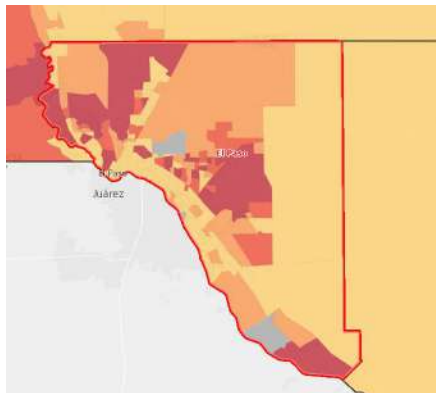

ACS 2018-22

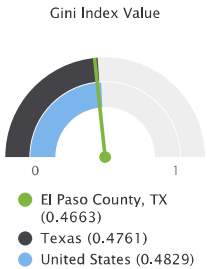

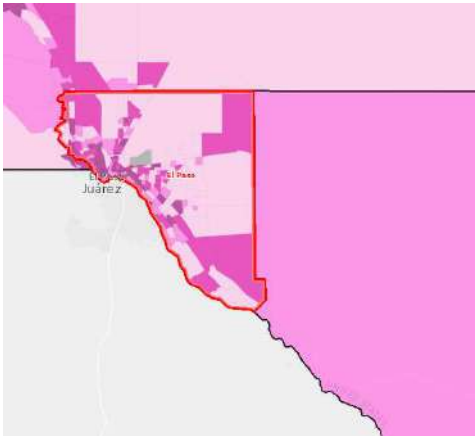

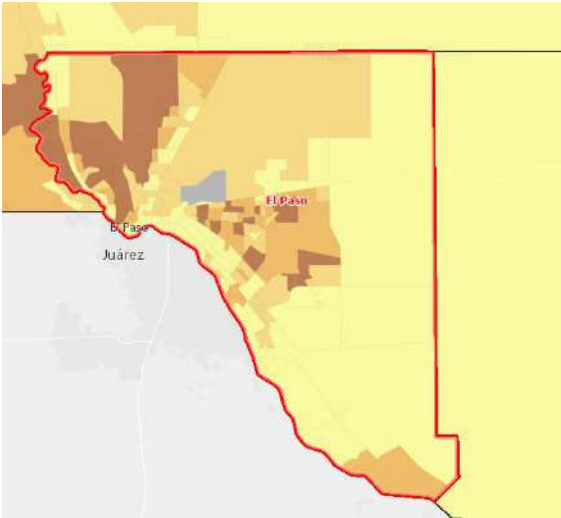

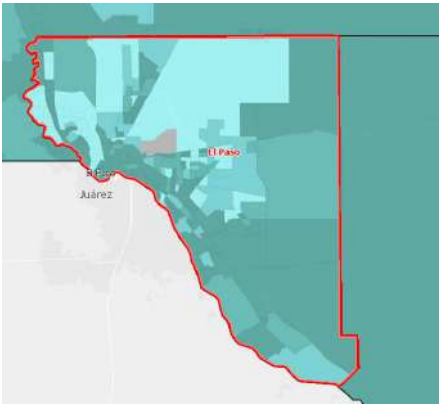
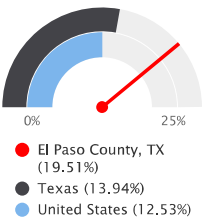

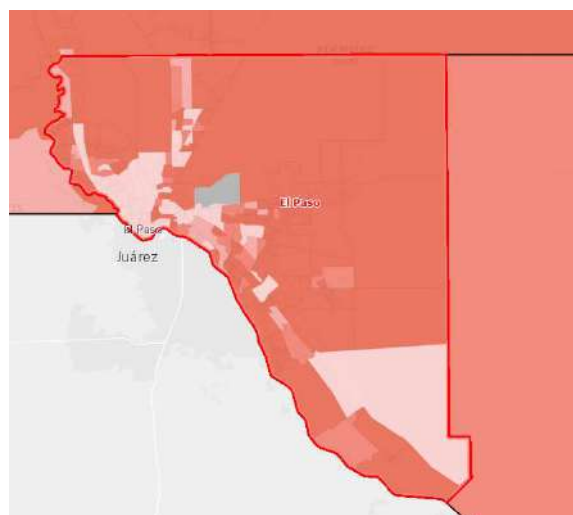
OVERVIEW

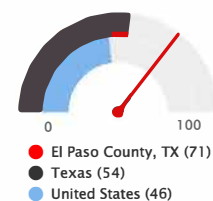

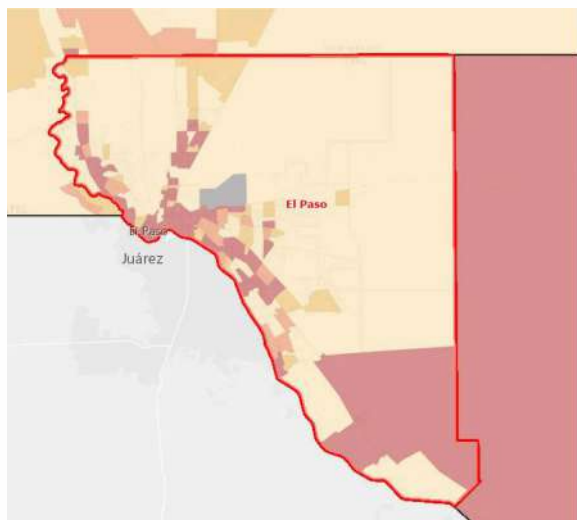

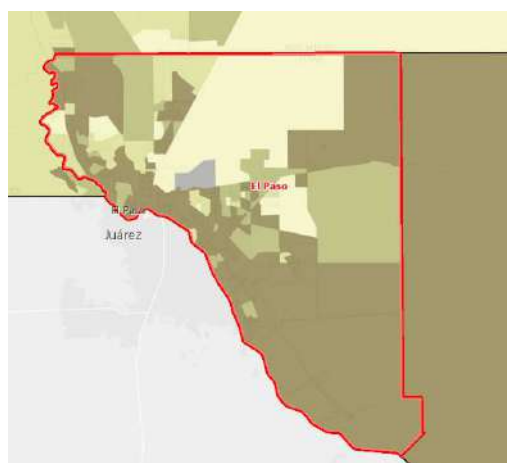
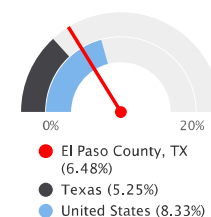

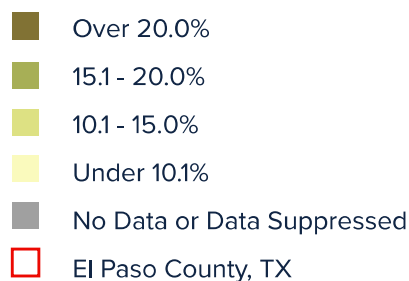

UNINSURED POPULATION, PERCENT BY TRACT, ACS 2018-22



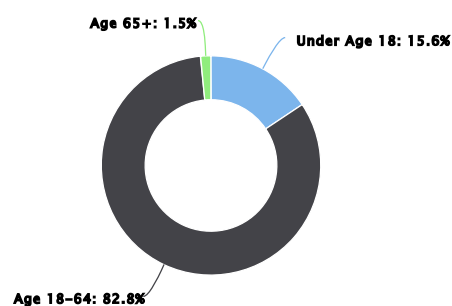

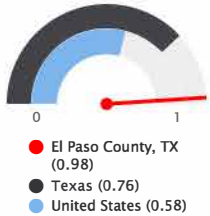
SOCIAL VULNERABILITY INDEX

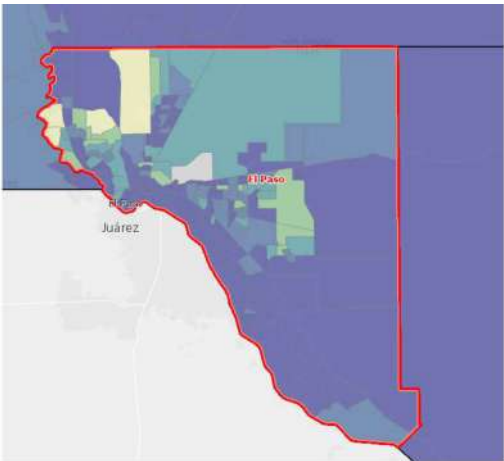

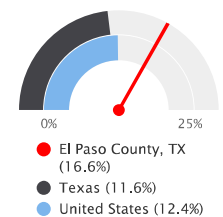

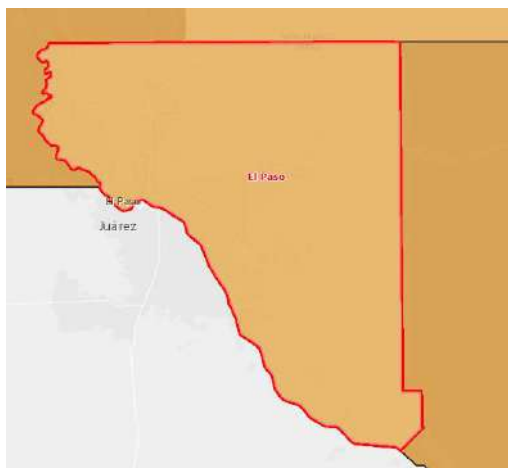

POPULATION RECEIVING SNAP BENEFITS, PERCENT BY COUNTY, SAIPE 2021

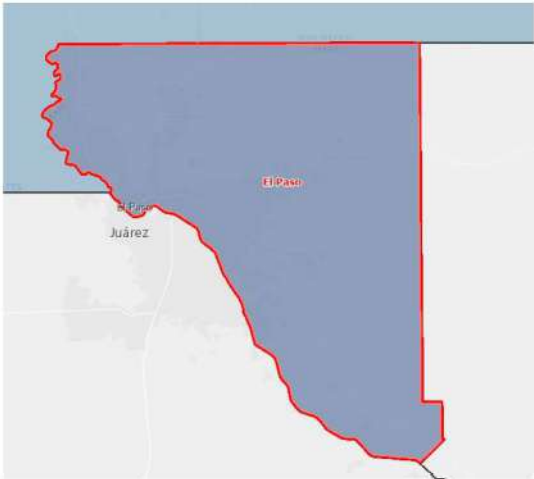
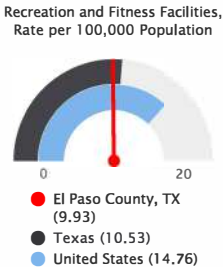

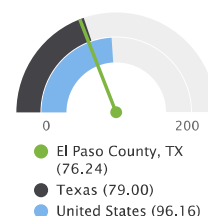

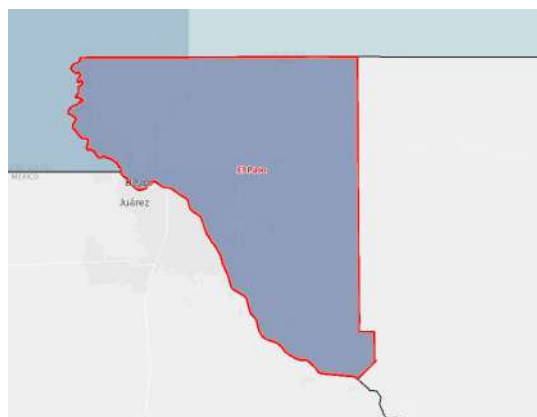

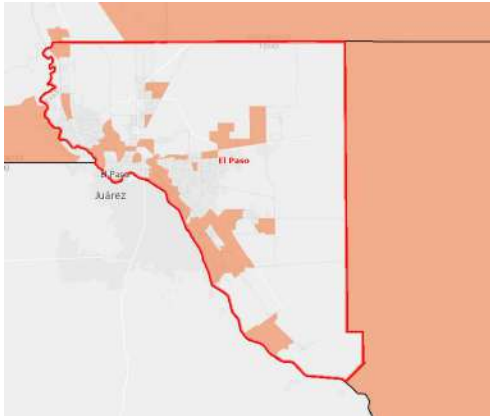
FOOD DESERT CENSUS TRACTS

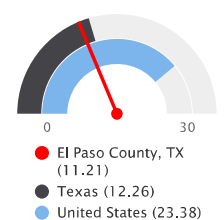

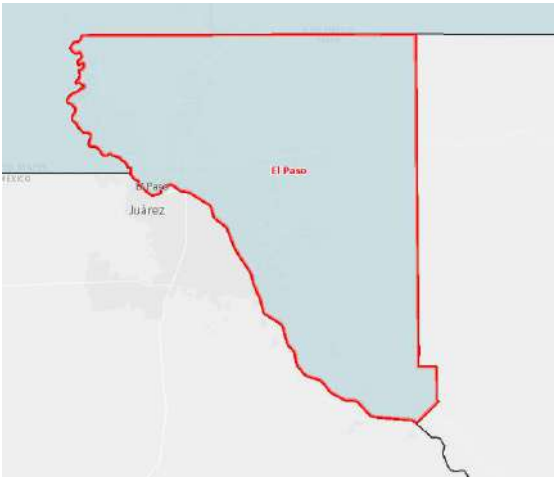

Grocery Stores, Rate per 100,000 Population





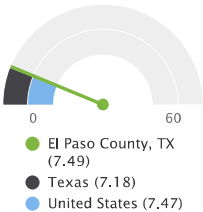

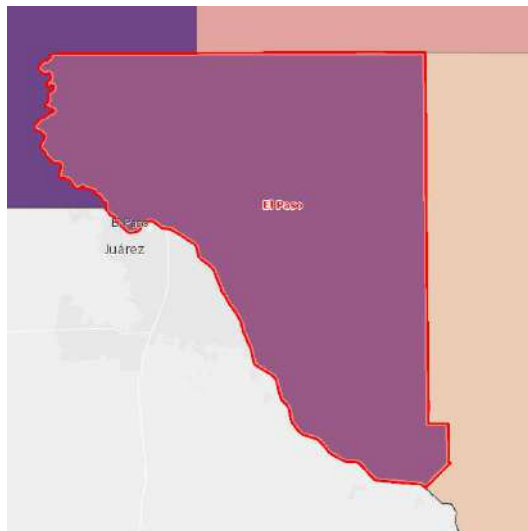
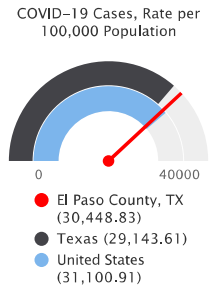
CONFIRMED CASES

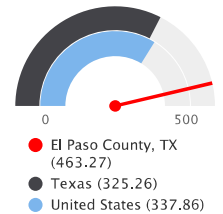

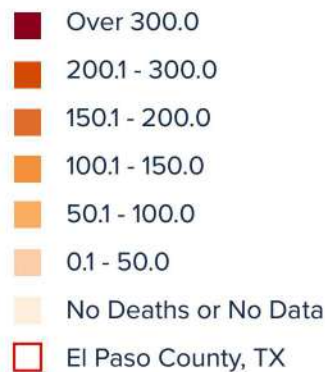

COVID-19 Deaths, Crude Rate per 100,000 Population

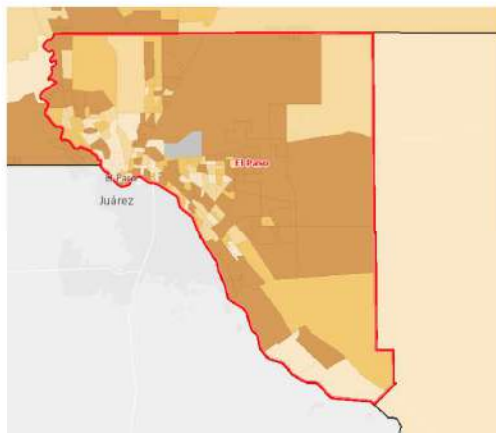


COVID-19 DEATHS, RATE PER 100,000 BY COUNTY, JOHNS HOPKINS 2022

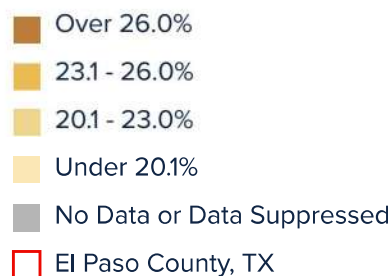


COMMUNITY PEDIATRIC POPULATION DEMOGRAPHICS

POPULATION AGE 0-17, PERCENT BY TRACT, ACS 2018-22

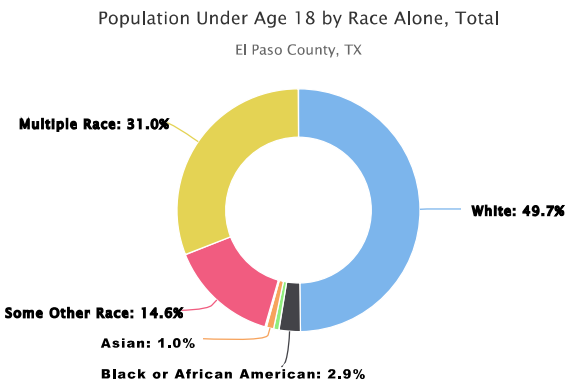


POPULATION UNDER AGE 18 BY RACE ALONE, TOTAL

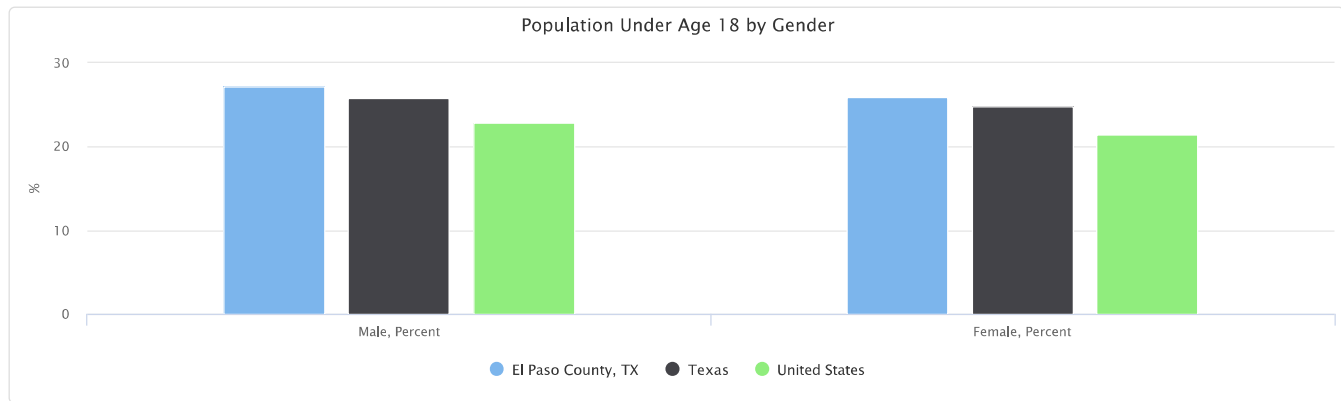

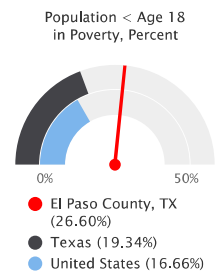
POVERTY - CHILDREN BELOW 100% FPL

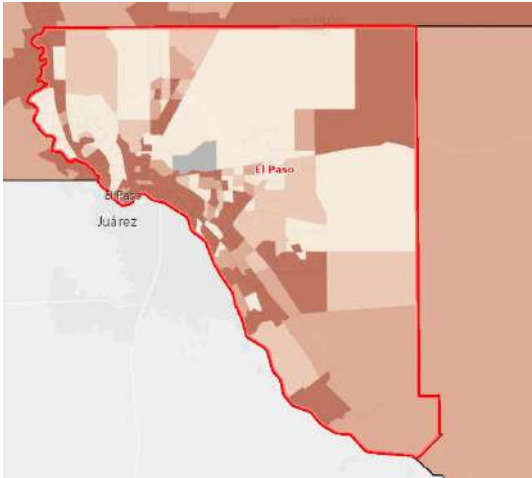

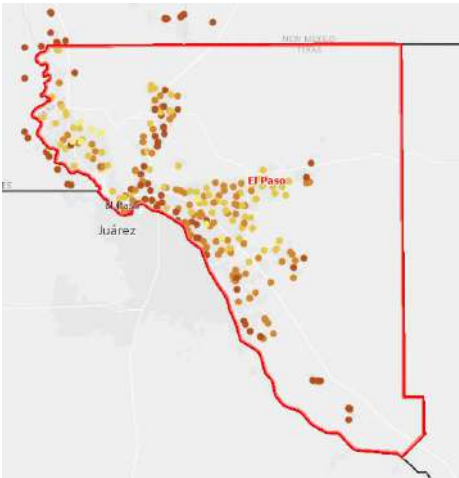
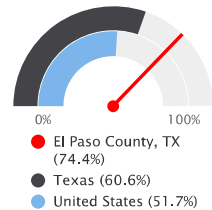

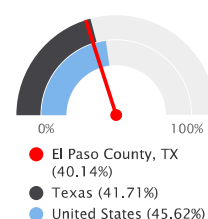

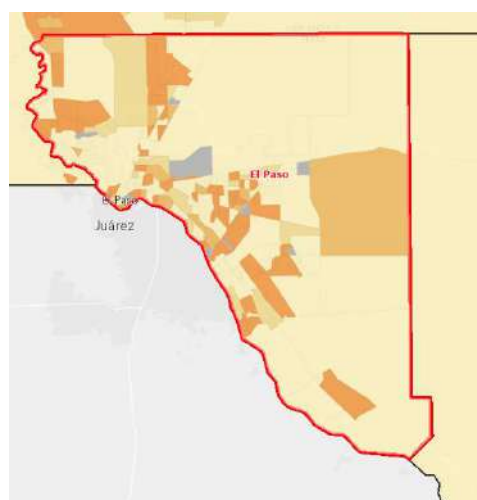

Percentage of Population Age 3-4 Enrolled in School

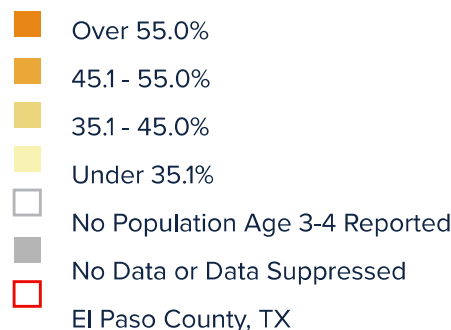

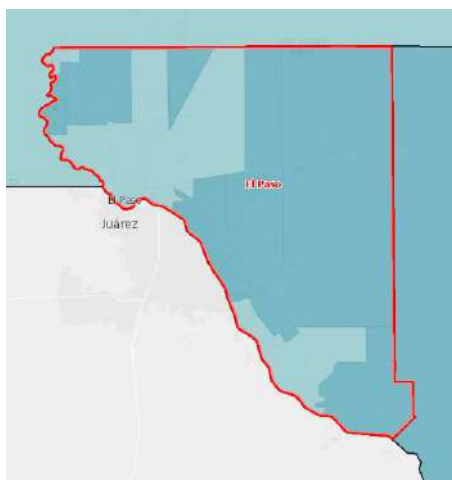
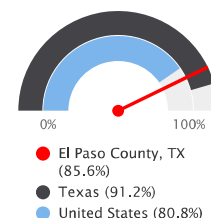

ON-TIME GRADUATION, RATE BY SCHOOL DISTRICT (SECONDARY), EDFACTS 2020-21

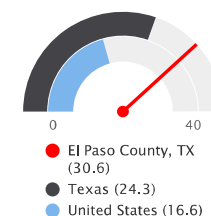

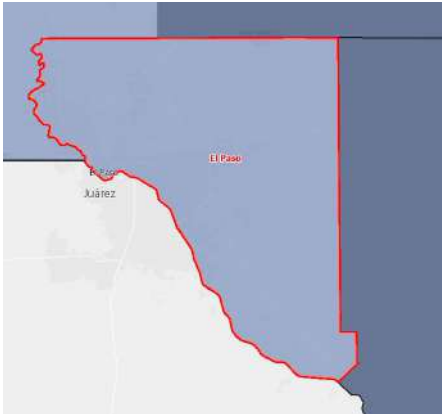
Teen Birth Rate Per 1,000 Female Population, Ages 15-19

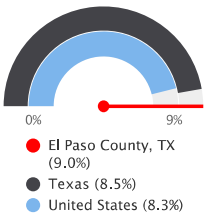

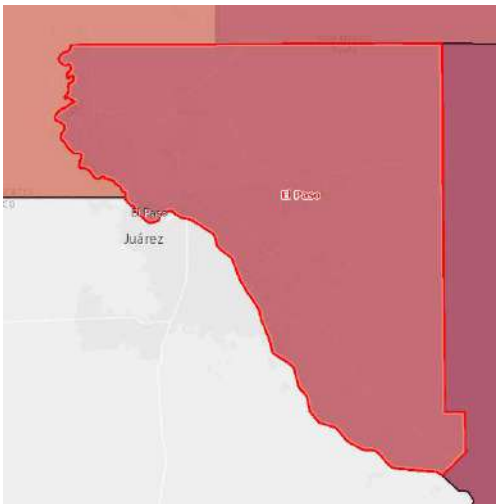

EPCH's Impact on Community

EPCH has endeavored to make a lasting impact on the health needs of the Community since its inception. Since the last EPCH CHNA was completed, EPCH is proud to note that it has made great strides in addressing the significant health needs of the Community. EPCH has outlined the following strategic imperatives (i.e. implementation plan) to address the significant health needs of the Community: 1) Outreach; 2) Program Development; 3) Community Engagement; and 4) Access to Care.

1. OUTREACH

Efforts to communicate with community physicians within EPCH's service area expanded in the last year. Additionally, Community Medical Education (CME) were provided monthly to physicians and clinicians across the region. The CME program is an initiative sponsored by EPCH designed to provide physicians and nurses a forum to learn about new services, procedures and updates in treatment protocols. There were also two symposiums sponsored in 2023, including a Craniosynostosis Symposium and Cleft Symposium. Both symposiums included participants from the Community, as well across the globe.

2. PROGRAM DEVELOPMENT

EPCH recruitment efforts continues to evolve. Since the last CHNA, a pediatric allergist/immunologist, pediatric neuropsychologist, pediatric urologist, pediatric otolaryngologist, pediatric dermatologist, pediatric psychiatrist, and several pediatric intensivists were recruited.



In collaboration with University Medical Center of El Paso, a neurosurgeon with a focus on epilepsy surgery was recruited. Additionally, EPCH received a new national accreditation with CODA (Commission on Dental Accreditation), as well as the Neonatal Intensive Care Unit (NICU) was redesignated as a Level IV NICU. A Vestibular Concussion clinic and a Hearing Aid clinic were launched since the last report. Access points were also established with the opening of a new Outpatient Rehab Center and Urgent Care Center to help serve the Community in remote locations. The addition of the new Multi-Specialty Center facilitates coordinated care between pediatric specialists to seamlessly transition the patient through the care journey.

3. COMMUNITY ENGAGEMENT

EPCH is committed to the Community it serves. Training was provided to several school districts for school nurses and athletic directors. EPCH partners with non-profit and other community organizations including sponsorship of community events with a pediatric focus including:

Data Collection Methods - 2024 CHNA

El Paso Children's Hospital collected data from two primary sources. The first primary data source was collected from in-depth interviews with Community leaders and stakeholders. An interview approach was chosen for its methodological strength in capturing perceptions of stakeholders relative to the primary areas of inquiry, including the Community health needs and strengths (including assets and resources), challenges and successes of working in their communities, and perceived opportunities to address these needs. The secondary data source was collected from the general and specialty pediatric medicine providers in the community with an electronic survey. Secondary data was collected using databases created by other agencies or organizations. Both primary and secondary data were collected to identify health needs within the Community.

The first primary data source EPCH utilized a semi-structured interview guide for data collection. The EPCH Compliance Officer, General Counsel, and external consultant, FORVIS, developed the interview questions through a collaborative process that began with an initial draft of potential questions prepared. The proposed questions were provided to EPCH Administration for their feedback. The EPCH Compliance Officer finalized the survey questions and survey protocols based on the feedback from the Administrative team. EPCH staff conducted the live interviews via a web conferencing tool in May of 2024. EPCH conducted interviews with representatives of the Community. These representatives attend to medically underserved, low-income, minority populations, as well as the populations with chronic disease needs in the Community.

The hospital remains the only certified Children's Oncology Group affiliated center in the region. Additionally, EPCH continues to serve as a training site for the next generation of pediatric specialists, skilled nurses and ancillary support staff, and provides research opportunities to advance pediatric health outcomes.

4. ACCESS TO CARE

Since the last CHNA, EPCH has grown and expanded access to care. In February 2023, the first pediatric focused outpatient rehab center was opened. The new rehab center also included a brand new teaching kitchen designed to provide cooking demonstrations to parents of diabetic and failure to thrive patients. In June 2023, the first EPCH pediatric urgent care center was opened in a highly underserved area of the Community. A grant in support of a mobile clinic was received in 2023, and will begin treating the most remote members of the Community in 2024. EPCH is extremely proud of its efforts and accomplishments since its last CHNA, and will continue to work diligently to improve in the areas of outreach, program development, community engagement, and access to care. While the hospital did not receive feedback on its prior CHNA from the Community, it will continue to engage with Community stakeholders to more fully understand the impact of its work in the aforementioned areas.

These local representatives included Dr. Hector Ocaranza, the Director of the El Paso Public Health Department, Tracy Yellen, Chief Executive Officer of the Paso Del Norte Health Foundation, and Shereka Barlow, Chief Executive Officer of the YWCA El Paso Del Norte Region – Community organizations representing the broad interests and specific populations of the Community. Each interview was conducted in English, recorded, and was about 30 minutes long. The interviews measured insight on a range of issues that affect the Community’s health and well-being. This included the lack of Community resources and the barriers to health care providers. This also allowed the providers to voice how the impact of such barriers effects the Community medically undeserved and how non-medical factors influence health outcomes. The interview guide is included as Attachment A. For the secondary data source, EPCH received input from general and specialty pediatric medicine providers in the Community. EPCH developed a series of questions for the providers on an electronic survey service to ensure a broad spectrum of input. All participants’ responses are anonymous. This survey helped gain more of a granular insight into the barriers that impacted the Community from the perspectives of individuals on the front lines of providing pediatric care in the Community. The electronic survey questions were developed in the same manner as the interview guide used by EPCH. The survey questions are included as Attachment B, and the individuals from whom information was sought are identified in the Appendix. In total, respondents are distributed across the entire Community and have intimate familiarity with the pediatric population of the Community, to include our Community’s most vulnerable populations. Additionally informing the CHNA is the collection of secondary data on a broad array of health indicators and demographic information of the Community.

Types of data collected included:

- Demographic information
- Chronic disease
- Morbidity/mortality information
- Health status indicators and health behaviors
- Family planning and births
- General Community/environment information
- Local, state and national benchmarks.

LIMITATIONS

Every attempt was made to collect relevant and recent primary and secondary data reflecting the health status and social determinants of health in the Community. Although financial and time constraints limited this assessment to the extent that they would limit any assessment of a community’s needs, no significant information gaps in existing information were identified. It is also important to note that data were collected at one point in time, so findings, while descriptive and detailed, should not be intended as definitive.

Community Health Resource Review

While there are pediatric providers and medical resources available within the Community, too many children are forced to seek specialty care far from their homes and families. Information and input from interviews and surveys conducted pursuant to this CHNA, furthermore, show the Community lacking in numerous areas of pediatric care.

There are nine hospital facilities in the Community able to address, in part, children’s medical care needs. EPCH, though, is the only independently licensed facility in the Community dedicated exclusively to the care of children. Hospital facilities in the Community include:

- 2. The Hospitals of Providence East Campus

- 3. The Hospitals of Providence Sierra Campus
- 4. The Hospitals of Providence Memorial Campus

- 8. Del Sol Medical Center
- 9. The Hospitals of Providence Children’s Hospital

Due to the scarcity of resources in the Community, many providers offer medical care regardless of ability to pay, charity care assistance to those in financial need, or discounts to non-insured patients. Prioritized Community Health Needs and Implementation Strategy

EPCH prioritized the Community's health needs. In order for EPCH to grow and continue to provide the Community with the medical services it needs, EPCH conducts a Community Health Care Needs Assessment (CHNA) every three years. EPCH pays specific attention to health care concerns that affect the Community's vulnerable population. EPCH was able to identify the top three health care concerns that the Community Stakeholders are most concerned about through this CHNA.

1. Obesity
2. Mental & Developmental Health
3. Neuroscience

PRIORITY1: Obesity

Introduced in the 2021 EPCH Community Health Needs Assessment, the EPCH Empower Program supports children in our Community struggling with obesity, pre-diabetes, and type 2 diabetes. What began as a program with 1 Registered Dietician in 2020, grew to 2 Registered Dieticians - one a Certified Diabetes Education Specialist - and a Social Worker by the end of 2021.

In 2022, the EPCH Empower Program saw its greatest leap forward with the opening of the EPCH Teaching Kitchen, where EPCH has been able to hold live, in-person and virtual cooking classes in partnership with Downtown El Paso Lions Club and El Paso Community College Culinary Arts Program. These two partners provide the ingredients to all individuals who register for each class, even those participants attending the classes remotely, through the Kelly Food Bank. Teaching Kitchen Chef Nickerson also prerecords preparation videos for families prior to the live class to teach families how to cut vegetables. The Teaching Kitchen truly has provided families with the knowledge and experiences they need to normalize healthy eating in their day-to-day lives.

To date, the Empower Program has assisted more than 1,000 children and their families, and its impact on childhood obesity, pre-diabetes, and type 2 diabetes will only continue to grow. EPCH has partnered with the El Pasoans Fighting Hunger to provide Empower Program patients who meet food insecurity criteria access to the El Pasoans Fighting Hunger Food FARMacy, where they receive fresh produce and healthy dry foods, such as beans and lentils, on a weekly basis. In addition, EPCH will continue to support children in our Community struggling with obesity, pre-diabetes, and type 2 diabetes through 1) continued expansion of cooking classes offered through the EPCH Teaching Kitchen, 2) growth of the Food FARMacy collaboration, and 3) creation of additional outreach and education initiatives for the children and families of our Community.

PRIORITY2: Mental & Developmental Health

The lack of mental health and other developmental services was again identified by our Community partners as an area of concern, ripe for opportunity to impact the lives of our Community's children.

EPCH has made strides in expanding access to mental health care services since its last CHNA. In that time, EPCH has recruited a full-time Psychologist and full-time Neuropsychologist to provide outpatient services at its Behavioral Specialists. Successfully expanding the availability of much needed pediatric mental health care in the Community.

Looking forward, EPCH is committed to addressing the most pressing needs in this area: the availability of pediatric mental and developmental health services on the weekends and the availability of inpatient mental health care. The data clearly shows

that the Community has many households who have multiple earners, working multiple jobs. Weekend availability is critical to address these families' needs. EPCH will work to recruit new providers, and work with its existing physician resources, specifically for the purpose of making mental and developmental health services available on weekend. EPCH is also partnering with the Community wide Mental Health Collaborative working to establish a new psychiatric hospital in the Community.

PRIORITY 3: NEUROSCIENCE

EPCH is committed to addressing the critical needs of the Community by expanding our neuroscience program. In response to concerns raised by Community partners about the lack of pediatric neuroscience services in the Community, EPCH will continue its collaborative efforts with TTUHSC to bolster our existing pediatric neurological service offerings. This partnership is a key to ensuring that children in our Community have access to high-quality neurological care close to home.

Looking ahead, we will continue to strengthen our recruitment efforts to attract and retain highly skilled providers. Our goal is to build a robust neuroscience team who can meet the current and future demand for pediatric neurologic services, ensuring that every child in need of neurological care in the Community receives timely and effective treatment close to home.
